The savings by departments could provide some cushion to the government, which could postpone the mega IPO of the Life Insurance Corporation (LIC) to next financial year.

Adelay in the LIC issue to the next fiscal could strain the gov-

ernment's finances as it has factored in about ₹60,000 crore receipts from the IPO in the revised (RE) disinvestment revenues for FY22. Already the disinvestment target for the current fiscal has been pruned to ₹78,000 crore in RE from ₹1.75 lakh crore envisaged in the budget estimate. So far in FY22, the proceeds from divestment have been a paltry ₹12,424 crore.

While surrendering the savings, the excess or shortfall in recoveries, if any, in the respective Grants against the original estimates of recovery may also be furnished, the memorandum said.


